

Reconstruction of this interchange would complement the work the City of Hays has already done in the area, provide opportunities for economic development and was identified as a high priority during Local Consult discussions.

The original scope for this project called for reconstructing a 22-mile stretch for \$53 million. We identified the most important segment in the 22-mile corridor so that we could begin sooner. This project will help with economic development, accommodate increasing truck traffic and was identified as a high priority at Local Consult.
