#### PROJECT OVERVIEW

The Kansas Department of Transportation (KDOT) is completing preliminary design of the U.S. 400 Bridge Replacements project east of Mullinville.

The project is redesigning the U.S. 54 and U.S. 400 junction, replacing two bridges on U.S. 400 (over U.S. 54 and the Union Pacific Railroad) with one structure to improve vertical clearance and increase roadway width.

The team is also exploring intersection improvements at U.S. 54 and 10<sup>th</sup> Avenue as well as U.S. 54/U.S. 400 and 15<sup>th</sup> Avenue.

This project is currently in preliminary design. Once the design is advanced, and there is local support, it would be eligible for the IKE Construction Pipeline. Once selected for construction, a timeline would be provided. The soonest construction could begin is spring of 2025. It is anticipated U.S. 400 would be closed during construction and traffic would be rerouted to U.S. 54.

The U.S. 54/U.S. 400 corridor currently carries about 5,500 vehicles, including 1,900 trucks, daily. The goal of the project is to replace the aging bridges, reduce future maintenance costs and enhance safety along this corridor.
